### **Informed Consent Form for Adopt an Inmate Studies**

AI is asking you to take part in a research study. This form will give you information about this study. Please read this form carefully and ask any questions (by phone or mail) you may have before agreeing to take part in the study. (Note: Participation in the study is not required to be placed on our waiting list for adoption.)

Project: Perceptions in Prison / Contact Person: Melissa Schmitt 971-236-7897

What the study is about: The purpose of this study is to gather data about U.S. prisons and prisoners, and how people in prison view their experiences.

What we will ask you to do: If you agree to be in this study, we will ask you to: Complete pages 1-3 about your perceptions of how you've been treated in the courts and in confinement. The survey questions usually take about 20 to 30 minutes to complete.

Risks and benefits: There are no direct benefits to taking part in this study other than that people on the outside will have a better understanding about how people on the inside view their treatment. Indirect benefits include contribution to science, which we hope will improve upon past studies by including a broader number of participants, and data collected directly from prisoners. We do not expect any risks for taking part in this study. Some questions may ask for sensitive information. However, your answers will be confidential. Your answers are being collected and entered in our database and will be stored on in a secure environment. Despite these measures, there is always the risk that an outside person could view your answers.

Confidentiality: Data are stored on password protected computers. Any paper surveys will be kept in locked rooms. Any online data will be password protected. Only people authorized by *Adopt an Inmate* will be able to view your answers. The data may be viewed by students, trainees, volunteers, and professional researchers. In any sort of report we make public, we will not include any information that will reasonably allow someone to identify you. We may keep your data for future research.

You or someone you authorize may freely release information about yourself or your involvement in this study.

Data from this study may be shared with other researchers. Before we share any data, we will remove or code any personal information that could identify you to ensure that, as far as we know, no one will be able to identify you from the data we share. However, we cannot guarantee that your personal data will be anonymous.

Taking part is voluntary: Taking part in this study is completely voluntary. Unless you feel uncomfortable answering a question, please answer every question. It is better to answer than to leave it blank (even if you are unsure). If you decide not to take part or not to complete the study, it will not affect your current or future relationship with Adopt an Inmate. If you decide to take part, you are free to stop at any time or to skip any question.

If you have questions: Please submit any questions you have now, either via phone (we are unable to accept collect calls), USPS mail, or electronic messaging if it is available in your institution. If you have questions later, or wish to withdraw your participation, you may contact us in the same ways.
